#### **Presidents Report**

During the off season between 09/10 a few of us got together and discussed what we believed to be was the best way to go forward with Warringah Rugby club. This discussion encompassed many facets including our historical performances both on and off the field, were we saw club rugby going and what opportunities and challenges we would meet.

A few things became quite apparent, we had spent considerable amounts of money to win a Shute shield without success, our financial membership was at an all time low, our sponsors were being hit with a downturned economy and there was a deep concern as to where club rugby fitted in within the larger framework and plans of Australian rugby.

We clearly identified a number of points:

- Club rugby could not sustain the level of player and coaching costs
- Super Rugby competition would be extended.
- Super Rugby players would become unavailable to clubs due to the extended Super rugby competition and overseas offers.
- Sponsorship for club rugby would continue to be a hard sell.

We commenced a program in 2010 of building from within our ranks. These ranks encompassed our own WRC community, Warringah Junior's, village clubs and of course schools. We always foresaw this program as a long term proposition and it continues today and has expanded to developing contacts in country areas.

Season 2011 was by no means a successful season on the paddock competition wise. We did show a lot of promise in many of our performances and this can be clearly identified through individual match results. The number of games lost by 10 points or less clearly shows we are on the right track. Our wishful thinking is that we identified the challenges well in advance and hopefully have a jump on some of the other clubs leading into this new stage of club rugby.

Other positives to be taken from season 2011 and the build up to season 2012 is the player numbers and commitment. Our colts development program led by Jed Hogan is coming along extremely well and I believe for the first time in a long time with have become the automatic club of choice for many of our juniors. I know this will be a controversial statement but our colt's numbers have been very poor for the last few seasons and this has been due to key players amongst our junior ranks heading to other clubs once they finish their junior footy.

In grade the appointment of Sam Harris as 1<sup>st</sup> grade coach though controversial at the time has been a very positive move by the club. He has brought a modern approach to the club both in coaching and culture. He expects what he gives which was clearly demonstrated by him strapping on the boots in literally all senior grades this year. The off season program he has developed in conjunction with Greg Highfield and which has been running for the last 6 weeks clearly demonstrates his commitment to a winning culture, it is also truly infectious with great turnouts for this off season program.

My strong belief is that club rugby is at a major turning point and the future of club rugby is in the hands of the administrators and the patrons. What is required is a larger fan base and a higher profile for club rugby. Club rugby must be clearly identified as the development program for super and national rugby. It needs to be marketed that way and all players should be aware that performances shown at club level can be used to catapult them onto the larger stage.

To this end the Sydney Rugby Union has revamped the competition for 2012; this has all been done in conjunction with the ARU and has some very clear identifiers. Bring up the standard of club rugby, strengthen clubs and re introduce the importance of the club championship and ensure that a development program is in place within the clubs. The other concerns was that while clubs are developing young players and these players are regularly coming up against established super rugby players the injury toll from a 22 round season has been a nightmare. No club more than Warringah can attest to that. Blooded 60 players in 1<sup>st</sup> grade last year at one point during the season had an injury list of over 30 players.

The outcome is that season 2012 will be a 16 round season with an 8 team final series. How this will work is as follows.

First 11 rounds are the standard home and away, after the completion of the home and away rounds the competition will be split into 2 pools based on club championship points. (Individual teams will carry over their competition points). The teams in each pool will play each other and a top 8 will be established and move onto the finals. The season will work in unison with Super Rugby and will endeavour to raise its profile by the inclusion of Friday Night and Sunday games with the possibility of some Saturday evening. This will not be a norm as Saturday afternoon rugby is our traditional time and to be frank Saturday afternoon at Rat Park with a few beers and some good company can't be paralleled anywhere.

As a club we feel we have our internal structures in an Ok position, coaching and playing ranks seem very strong. From a back room perspective as a club we desperately need to grow our off field membership. As I mentioned earlier we were at an all time low with only 45 members we have now stagnated at about 210. Our 100 club shouldn't really be called that as it only has 61 members. What I can't believe is that we struggle for membership when other clubs who in my opinion do not have anywhere near the amount of avid supporters can't keep up with membership and 100 club membership, so much so that some clubs have gone from 100 club to 200 club now to 300 club. I think that these clubs have developed a tribal type culture and have also developed a mantra that you played for us and had some fun, now put back in and help us be strong so future generations can enjoy what you enjoyed.

Season 2012 will be a great improvement on season 2011 the boys fully appreciate the support they get and so do I. I would dearly like to thank the current board and volunteers/committee members for their support and input and most of all you the members who through thick and thin are there to support the club.

In saying that we still would appear to lack the depth of engagement from members and players off the field that perhaps other Clubs enjoy but I do think it is improving and is probably a reflection of the changes to ground control that happened a few years ago.

#### Warringah Rugby Club Colts - 2011

The 2011 Rugby season began in earnest with a changing of the guard occurring with Phil Brown, Head Coach with Colts departing Australia for the greener pastures of the United Kingdom for the next couple of years. Thanks go to him in terms of his dedication and thoroughness to coaching of the players over seasons 2009 and 2010.

Jed Hogan replaced Phil Brown as Head Coach and in so doing the Warringah Rugby Club gained another former 1<sup>st</sup> XV CAS coach this time from Trinity Grammar School, joining the distinguished group of coaches that have coached at Colts level at Rat Park.

2011 Rugby season saw the Club ably led with Colts Coaches in 2<sup>nd</sup> Grade being Bruce Nicholas and Andy Fairful while 3<sup>rd</sup> Grade was coached by Adam Smyth and Stu Nolan. Welcome additions through the season saw Graham Collelo returning after a few years absence to assist Jed Hogan in 1<sup>st</sup> Grade and Scott Reid covering in Jed's absence while on duties with NSW Schools XV in Brisbane with the National Rugby Schools Championships in July. Scott kindly then stayed on for the remainder of the season enabling Jed to assist further all coaching staff and co-ordinate all three Colts grades. Another notable addition was Jasmin Hadzipasic who assisted Adam Smyth and Stu Nolan with 3<sup>rd</sup> Grade Colts.

Preseason saw our numbers in Colts fluctuate from a core group of twenty five players before Christmas to more than fifty at various stages before matches against a Central Coast club team, Penrith and finally North's. We were probably as a group, a little hesitant, and underdone before our 1<sup>st</sup> fixture against Randwick away. Not helped by the unavailability of a number of players for the 1<sup>st</sup> and 2<sup>nd</sup> Rounds because of player's commitments with Surf Life Saving and various summer sporting commitments.

In the early rounds we were competitive but lacked that ability to finish games off. In Rounds 1 and 2 against high calibre opposition in Randwick and Manly in 1<sup>st</sup> Grade we were in the matches until various stages in the second half. The ability to focus and stick to the game plan faltered because of lack of intensity and general fitness. Our match against Manly in particular emphasized the difficulties of players unavailable for the early rounds of the season.

In my book both of these matches were winnable but certainly were matches where we saw players putting their bodies on the line.

The next couple of matches saw us back in the winner's circle for 1<sup>st</sup> Grade with positive results in wet conditions against Gordon, Parramatta before being outclassed by an Eastwood side that we were competitive against for the first 25 minutes of the match but didn't show a resolve in the later 55 minutes of the match. Both players and coaches were disappointed with all three Grades against Eastwood, encouraging being the closeness of our 3<sup>rd</sup> Grade Colts match. This team throughout the season would show some grit and determination in a number of matches and it will be interesting to see how these players develop into 2012 and 2013. Encouraging results which in the weeks ahead may see them surprise a number of opposition teams.

We then travelled across to Woollahra to play East's. Unsure of what happened in the travel across the bridge or whether the physical nature of the match had taken its toll but in 2nds and 3rds we were certainly shown lessons in playing field position and getting the little things right, particularly at the breakdown - commitment of numbers and taking our opportunities. 1<sup>st</sup> Grade players would agree that with a 3 to 0 lead at half time the need to play field position and the onus and pressure on the home team placed us in a good position. These experiences we hopefully learnt from. Another trying difficult day at the office!

Round seven saw us pitted against West Harbour at home. This was a physical encounter where all three Grades learnt a little about broken play from anywhere on the field and the ability of the opposition to take their opportunities. Each Grade had their opportunities but didn't finish the opposition off – this was as the season panned out – the way of the season, so close but so far away from the goal of winning matches.

Our next round of matches saw us play Penrith (only 3<sup>rd</sup> Grade Colts), North's, Southern Districts and Sydney University. Wins against all three of these sides in all Grades was encouraging before our final home match of the first round of competition matches against University. Each of our teams certainly gave it their all, 1<sup>st</sup> Grade pushing the opposition, leading at half time and then giving the opposition too much space and field position. The coaches were certainly disappointed knowing that it was a match that had got away! 2nds and 3rds were certainly not outclassed and it would be interesting to see how we did against them later in the season.

A weekend off at Queen's Birthday saw us regroup ready for the second round of matches. Critical injuries were certainly starting to test our depth and these next three or four matches were certainly going to determine whether the sides were going to be in semi-final contention.

Randwick and Many at were going to be big asks. With Randwick, it was the adage of the one that got away- the catch phrase for 1<sup>st</sup> Grade Colts a 26 – 20 loss, so close but unfortunately not the victor. For third Grade a credible 13 to 12 win against Manly certainly set the cat amongst the pigeons that day. Again depth and the size of the opposition certainly told on the day "Danny" came to play. The Colts boys were again disappointed but certainly gave their all on the day. Early missed opportunities placed us on the foot in both 1<sup>st</sup> and 2<sup>nd</sup> Grade Colts and this placed us behind the eight ball and caused us to start having to take chances which are always difficult Rugby.

The local derby against Gordon was a cracker with matches seeing Warringah the winner in 1sts and 3<sup>rd</sup> Grade Colts. 3rds had a storming game and put the cleaners through them. Then we hit Parramatta on back to Parra Day at Death Valley. This was to be the defining moment particularly in 1<sup>st</sup> Grade Colts. The boys had certainly not come to play! They went through the motions and were beaten by a team who out enthused and generally took their opportunities on the day. A great deal of soul searching went on after this match and certainly for coaches and players alike was difficult to contemplate as we had shown throughout the season a much better team that was shown on the day.

Our next set of matches saw us play Eastwood at TG Milner, East's at home and West Harbour away.

All three matches were critical for all teams making the Semi's. Unfortunately it wasn't to be but the

Warringah pride and ability to fight well above ones weight certainly showed. The 2<sup>nd</sup> Grade side against Eastwood certainly gave the opposition a run for their money. Right to the final play of the match Warringah was winning only to be denied in the last 20 seconds. Oh so close, a great match to watch where Eastwood were rattled and were certainly on the ropes. This display was encouraging as a number of these boys will be back for next year. These rounds of losses certainly put pay to our semi-final aspirations however even with four rounds to go we still had a slim chance in a couple of Grades. Pride was on the line and over the last few weeks the boys certainly took it to each of the teams we opposed.

Northern Suburbs in the wet at home, reminded me more of a pleasant day back home in New Zealand rather than beach weather in Warringah. A resounding thumping in 1<sup>st</sup> Grade and the running on of a few players in 1<sup>st</sup> Grade, Grade made for interesting chatter amongst the spectators and certainly showed to all that the future at Rat Park will be in these young players coming through the ranks from Colts.

Southern Districts was a dull affair with a great deal of negative play from the opposition making more of a physical contest in each of the matches. All grades were won by Warringah. Our final match of the season saw us play Sydney University at St Paul's College Oval. Sydney University playing area is certainly an impressive ground within the confines of the University. Each Grade gave it all and 3<sup>rd</sup> Grade once again gave its all, nearly winning in the dying stages of the match and getting across the line. Both 2nds and 1sts once again had their opportunities but gave the opposition too much latitude in terms of space and territorial advantage.

They have and did an amazing job and without their help my job as Head Coach of Colts would have been that much harder. We conducted a recent 'think tank' and there were some real synergies which were bought to the table and some obvious links in juniors, colts and seniors were identified and a willingness to consolidate which might not necessarily have been there previously.

As President, I attended as many meetings as possible throughout the year, including being very local on behalf of Rugby, in turn on behalf of the Sporting Union, fighting against the increased player levy fee introduced by Warringah Council, joining the new development discussion group (under the SJRU banner) where representatives from the ARU, NSWRU, SJRU and all Sydney districts come together once a month to discuss the development of Rugby, attending Council Meetings, MNZ meetings, Representative meetings and most importantly the Warringah Rats Meetings, where the bond between the Junior and Senior Club has strengthened significantly, evident recently with both the Senior's President, Mike Sheeran, and General Manager, Mike O'Carroll, attending the Juniors AGM. We look forward to further strengthening these ties in the future.

The 2012 committee will commit itself to work closely with all the Warringah junior rugby clubs but in particular, forge a greater bond with the senior club and its committee

### NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 SEPTEMBER 2011

#### 1 STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The financial report is a Special Purpose Financial Report.

The financial report is for the entity Warringah Rugby Club Limited as a single entity. The Warringah Rugby Club Limited is a company limited by guarantee, incorporated and domicilied in Australia.

The financial report has been prepared in accordance with the requirements of the Corporations Act 2001, except for the following directors' determination.

The directors have determined that the financial report be prepared as a Special Purpose Financial Report. The directors' determination is made cognisant that the company is a reporting entity under the provisions of Part 2M of the Corporations Act 2001. The directors' determination is based upon the premise that a General Purpose Report places an unrealistic administrative requirement on the company.

The following Australian Accounting Standard has been applied in the preparation of this report:

AASB 101: Presentation of Financial Statements

No other Accounting Standards or other authoritative pronouncements of the

Australian Accounting Standards Board have been applied.

The financial report has been prepared on an accruals basis and is based on historical costs. It does not take into account changing money values or, except where stated, current valuations of non-current assets. Cost is based on the fair values of the consideration given in exchange for assets.

The following is a summary of the material accounting policies adopted by the company in the preparation of the financial report. The accounting policies have been consistantly applied, unless otherwise stated.

- (a) Income Tax No provision for income tax has been raised as the company is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.
- (b) Inventories Inventories are measured at the lower of cost and net realisable value.
- (c.) Property, Plant and Equipment Each class of property, plant and equipment is carried at cost or fair value as indicated, less, where applicable, accumulated depreciation and impairment losses.

# NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 SEPTEMBER 2011

(c.) Property, Plant and Equipment (cont.)
Plant and equipment is measured on the cost basis.

The carrying amount of plant and equipment is reviewed annually by the directors to ensure it is not in excess of the amount recoverable from those assets. The recoverable amount is assessed on the basis of the expected net cash flows which will be received from the assets employed and their subsequent disposal.

The depreciable amounts of all fixed assets are depreciated over their estimated useful lives to the company commencing from the time the assets are acquired and held ready for use.

#### (d) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less and net of bank overdrafts.

#### (e) Revenue

Revenue from rendering of a service is recognised upon delivery of the service to the customers. Other revenue is recognised when the right to receive that revenue has been established. All revenue is stated net of the amount of goods and services tax.

#### (f) Goods and Services Tax (GST)

Revenue, expenses and assets are recognised net of any GST except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or the expense item. Receivables and payables in the statement of financial position are shown inclusive of GST.

Cash flows are presented in the statement of cash flows on a gross basis, except for the GST components of investing and financing activities, which are disclosed as operating cash flows.
